October 13, 1982

The Mt. Joy Township Supervisors held their regular monthly meeting on Wednesday, October 13, 1982 at 7:30 p.m. at the township municipal building on Hoffman Home Road. All members were present.

The minutes were approved by motion of Jim Neth, 2nd by Harry Hilbert, carried.

The treasurer's report was approved by motion of Neth and 2nd by Glenn Snyder, carried.

The flail mower has arrived, but has not yet been installed. Snyder to call Joyce of D.W. Miller and find out when they will be here to install the mower.

A special Revenue Sharing Hearing was held for the purpose of receiving oral and/or written testimony or comments from interested parties with respect to the possible use of the funds expected to be received during the fiscal year 1983 under the Federal Revenue Sharing Program. Revenue Sharing allocation for the 1983 fiscal year is \$22,780.00. The monies are to be allocated as follows:

SPCA - \$150.00

Adams County Public Library - \$300.00

Rec Board - Gettysburg - \$200.00

Rec Board - Littlestown - \$200.00

Fire Companies - \$1,100.00 (Littlestown and Barlow each 30%, 20% each to Gettysburg and Bonneauville, \$100.00 to Kingsdale.)

Ambulance Service - to be decided upon at next meeting.

It will cost approximately \$4,450.00 for C.E. Williams to excavate Clapsaddle Road in lieu of \$3,550.00.

Dave Kemper was present at meeting requesting radio for his car. Floyd Huff said he doesn't need a radio. Neth read letter from Sam Teeter which states that he does see the need for Mr. Kemper to have a radio. A motion was made by Neth to give Mr. Kemper the authority to lease a radio from Mt. Joy Township upon signing the proper documents and producing evidence of proper insurance coverage, all costs to be incurred by Mr. Kemper. Motion died for lack of second. Supervisors to contact solicitor to make certain that they are not liable for radio in case of misuse.

Resolution was read about the inspection of bridges. Snyder made a motion to sign resolution agreeing to the county inspection of Township bridges, 2^{nd} by Hilbert, carried.*

Barlow-Two Taverns Road is T-405. Township now has 38.84 miles of road.

Nothing to report on workman's compensation.

West Mannheim Township Sludge Ordinance - Neth has received a copy of this ordinance. File away for future use.

Tractor and mower to be sold. Secretary to advertise for bids to be sold to the highest bidder at next regular meeting, November 10, 1982 at 7:00 p.m.

Meeting adjourned at 9:30 p.m. by motion of Neth, 2nd by Snyder, carried.
