Road takeover - Supervisors met with Charlie Scoot and someone from Penn Dot. The state is very anxious for township to take over roads. State would rather repair roads for township. Harney Road is all right as is. Fish and Game road is scheduled to have a new top on next year. If Harrisburg decides before township that township is to have these roads, township gets them in the same condition as they presently appear. We would get \$1,100.00 per mile state aid. No final decision will be made at this time.

The Revenue Sharing Hearing will be held on Thursday November 19, 1981 at the township municipal building.

Letter read from soil conservation agency concerning the washing of soil from the banks at Davies Salvage Yard. Snyder suggested that township clear the area and give Davies a letter stating that he will have to seed the area per the letter from the soil conservation agency.

Also discussed was the situation about the water from property adjacent to the Richard Kelly property. Mr. Kelley says DER told him its not their problem, sent him to see Dean Shultz. Shultz said to start civil suit against party. Indirectly it is a township problem that the supervisors said they will check out when they work on Highland Avenue.
