The Mt. Joy Township Supervisors held their regular monthly meeting on Friday November 9, 1979 at 7:30 p.m. at the township municipal building on Hoffman Home Road. All members were present.

The minutes were approved by motion of Glenn Snyder, 2nd by Wilbur Danner, carried.

The treasurer's report was approved by motion of Snyder, 2nd by Danner, carried. The Steve Fisher plans were approved by motion of Snyder, 2nd by Danner, carried. The Gideon Stoltzfus plans were approved by motion of Snyder, 2nd by Danner, carried.

The Floyd Huff plans were approved by motion of Snyder, 2nd by Danner, carried.

Mr. Oren Wilson was present to tell the board about the work of the new SPCA which opened September 15, 1979 outside of Gettysburg. He said during the first five weeks of operation there were over 400 animals (60% cats and kittens) brought to the new facility. At seven (7) weeks the total was over 560 animals. He suggested that Mt. Joy Township donated at least \$.15 per capita to this cause as there are animals from the township housed there. To take an animal there it costs a \$5.00 donation and to adopt an animal there is an charge, \$10.00 for a cat and \$15.00 for a dog.

A Revenue Sharing Hearing was held in connection with the regular meeting. This hearing is for the purpose of receiving oral or written testimony or comments from interested parties with respect to possible use of the funds expected to be received by the township under the Federal Revenue Sharing Program during the fiscal year 1980. Mr. Harry Hilbert was present and questioned why the township wasn't giving monies to the Kingsdale Fire Co. Supervisors told him they would consider during this next year when it is time to donate to the fire companies.

It was decided to donate \$300.00 to the Rec Park in Gettysburg. Also a donation of \$100.00 to the SPCA. Rest of Revenue Sharing is to be used for donation to Adams Co. Public Library of \$300.00, grader repair \$1,000.00 buy new road signs, and the balance to be used for road repair.

The Township Officers Convention will be held on Wednesday, November 21, 1979 at 10:00 at the Barlow Fire Co.

Mr. Floyd Huff was present and he requests a flagpole be erected in front of the municipal building. He was told by supervisors that they have the pole, but have not yet erected it. It will be done in the near future.

Ms. Eileen Holmes was also present at the meeting.

There will be a special meeting on Friday November 23, 1979 at 7:30 p.m. at the township municipal building on Hoffman Home Road.
