

October 5, 1977

The Supervisors of Mt. Joy Township, Adams County Pa. held their regular monthly meeting on October 5, 1977 at 8:00 p.m. in the election house. All members were present. The minutes were read and approved.

The Township Supervisors approved the George Long Subdivision Plans, also the Supervisors, with a motion to adopt the ordinance providing for the Establishing of Procedures for the use and maintenance of holding tanks in the Lake Heritage Area. Motion made by Clarence Myers and seconded by Wilbur Danner.

Mr. Eader was present and wanted the approval of the Supervisors to put a Tile on his property to avoid the run off of water from field and road from going into his pond. He was told to have subdivision plans if needed to determine where the boundary line is to adjoining property.

Mr. Teeter was present to inform the Supervisors that the New Rebidding plans for construction of the new addition to Township Building was not completed and thought maybe if the erection of the new addition could be built without the use of revenue sharing funds. If 25% OF Revenue Sharing Funds is used, the cost of wages must be paid at the prevailing wage in Penna. This has been tabled for the time being and probably will be recorded to include in the 1978 budget. The secretary was told to return the certified check in the amount of \$1,6000.00 which was being held for the 5% of the cost of the new construction, to Southeast Construction Co.

The supervisors have completed resurfacing of the Plunkert Road T-430. Put in place which was started on 8-31-77 and completed on 9-12-77. The necessary forms are to be completed and sent to the Department of Highways, Municipal Services. All the proper forms for County Aid.
