John S. Teeter and Sons Inc. All sizes of crushed stone \$2.10 per ton delivered and spread.

After a discussion of the bids, it was decided to award the contract to John S. Teeter and Sons. A motion was made by Albert Krug and second by Charles Gerver to that effect.

The members of board and Secretary are contacting John S. Teeter and Sons immediately after meeting for agreement and contract in regards to stone bid.

The county commissioners agreed to give said Township \$2,157.69 as county aid. The supervisors authorize Secretary to fill out Form 339 application for County Aid for Maintenance and Stone on all roads in Township where needed and fill same with County Commissioners, Adams Co.

A motion was made and second that we take out Group Insurance for Supervisors and Secretary, the Insurance administered by the Trustees for the Insurance Fund of the Pennsylvania State Association of Township Supervisors and it would be plan number three.
