The Board having advertise for sealed bids for 2500 tons more or less of crushed stone of various sizes to be opened Feb. 3rd at one o'clock p.m.

Three Bids were received and were opened by president of Board. L The Bids as follows:

John S. Teeter & Sons Inc., all sizes of crushed stone \$2.00 per ton.

W. V. Sneeringer & Sons Inc. #2 A Stones (\$1.95) per ton-All other sizes \$2.05 per ton.

Bethlehem Steel Co. #1B stone \$2.20 per ton, all other sizes stone \$2.10 per ton, Screenings \$2.05 per ton.

The Board awarded contract for stones to John S. Teeter and Sons Inc., Gettysburg Pa., as per their Bid.

The Board also received a bid from Stewart March Inc., York Penna., for FB-I material in place, this was tabled for information later on.

Two members of the Board (Myers and Krug) and Sec. are contacting John S. Teeter and Sons upon agreement and contract in regards to stone bid.

The County Commissioners agreed to give said Township \$2,157.69 as County Aid and was agreed by Board to hold the allotment over till the next meeting of the Supervisors to decide what roads the money is to be used on.

The Auditors advise by their minutes they met in session February 1st 1956 and set the following wage scale;

Foreman of Supervisors \$1.15 per hour, other members of board and labor at \$1.10 per hour. Supervisors attending meetings \$5.00 each. The Auditors set the amount of Treasurer bond at \$6,000.00 and further set compensation of Sec. and Treas. at 3% on all money paid out plus any special services.
