The Board of Supervisors of Mt. Joy Twp., Adams Co, Pa held their regular monthly meeting on above date at election house. -all members of board present Minutes of last meeting read and approved.

First business taken up was the board unanimously approved the budget for 1954 in the amount of \$19,866.87 and Secretary ordered to file a copy of same with the Department of Internal Affairs, Harrisburg, Pa.

Next item taken up was public liabilities Insurance amount of liability \$20,000 and \$40,000 dollars. Property damage \$5,000. Insurance was given for said amount to Mary Ramer, Gbg.Pa for a three year, policy amount of cash premium for said policy amount payable \$267.62 cash.

The supervisors signed project agreement with Department of Highways for matching fund, amount \$5,434.86 on a 30-50 basis. Agreement calls for Township Route #430 starting at a point on State Highways Route #140 extending to Mt. Pleasant line.

Next item Supervisor Krug presented a letter from S. E. Amspacker, York, Pa. in regards to road from Harry Hecks to Woodward property, earned table and Secretary was authorized t contact attorney J. Francis Yake Jr. for his advise, upon his decision Mr. Amspacker to be notified.

The president of board signed resolution for the levying assessing per capita tax for general revenue purposes.

Next item having advertised for stone bids the time arrived for opening said bids, tow bids presented

Wm. Sneeringer and Sons, bid 63 cents for stone delivered and spread on Township Roads.

Floyd E. Geiman bid 64 cents for same.

On motion of James Straley seconded by Clarence Myers that the contract for said stone hauling and spreading be awarded to Wm. V. Sneeringer and Sons.

President called for a vote, vote was unanimous for Wm. V. Sneeringer and Sons. An agreement developed about stone hauled by Geiman and charging them to Township which was out of order as Wm. V. Sneeringer and Sons have the contract to furnish stone for said Township.

The secretary was ordered to draw contract between Wm. V. Sneeringer and supervisors of Mt. Joy Township. Mr. Sneeringer and sons to file certificate of public liabilities insurance with Secretary of board.

A number of residents of Twp. were present and presented their cases to the board. Tax duplicate approved by board and ordered to be turned over to collector. Amount of tax duplicate for year 1954.
