October 14, 1993

The Mount Joy Township Supervisors held their regular monthly meeting on October 14, 1993, at 7:30 p.m. in the Mount Joy Township Municipal Building located at 902 Hoffman Home Road, Gettysburg, Pa. All members were present.

The minutes of the last regular monthly meeting, September 9, 1993, were approved by motion of Moul, 2nd by Snyder, motion carried.

The Treasurer's Report and Bills to be Paid Report consisting of \$46,924.72 to be paid out of the General Account, checks numbered 6786 through 6805; and \$2,237.20 to be paid out of the Payroll Account, checks # 1238 through 1243 were approved by motion of Moul, 2nd by Snyder, motion carried.

Mr. John Schwartz, representing Barlow Fire Company, presented a copy of the fire company's proposed budget for 1994. The proposed budget estimates expenses of \$124,000.00 and estimates receipts to be \$98,100 netting an estimated deficit of \$25,900.00 Mr. Schwartz expressed appreciation for the Township's support in the past and future.

Mr. Milburn Harris, who acted as Power of Attorney for Leonard Mohr from 1987 to 1991, was also present. Mr. Harris inquired regarding perc test made on the Mohr property during that period of time and again in 1993, as to why the results of the perc tests are different now. The Township will check with the Sewage Enforcement Officer regarding these perc tests.

Subdivisions:

Jean Sexton-County comments favorable; malfunctioning sewer system on the farm has been repaired. Subdividing 28.3 acres. Snyder moved the plan for approval, 2nd by Moul, motion carried, subject to DER approval.

Road Report:

Berms are being installed on the roads that were newly paved this summer. Ten miles of Township roads have been painted with a center line. Mowing is almost completed. Salt must e ordered for winter.
