

September 9, 1993

The Mount Joy Township Supervisors held their regular monthly meeting on September 9, 1993, at 7:30 p.m. in the Mount Joy Township Municipal Building located at 902 Hoffman Home Road, Gettysburg, Pa. All members were present.

The minutes of the last regular monthly meeting, August 12, 1993, were approved by motion of Moul, 2<sup>nd</sup> by Snyder, motion carried.

The Treasurer's Report and Bills to be Paid Report consisting of \$11,115.14 to be paid out of the General Account, checks numbered 6769 through 6785; and \$3,006.74 to be paid out of the Payroll Account, checks numbered 1232 through 1237 were approved by motion of Moul, 2<sup>nd</sup> by Snyder, motion carried.

Subdivisions:

There were no new subdivisions for discussion.

Bob Sharrah called in expectation of a letter from the supervisors and Dean Shultz; should be in writing regarding the run-off of water and the bond. Also, builder must design an alternative in case of failure. (Secretary instructed to write letter to Mr. Sharrah; builder responsible for run-off for two years or build-out, which is longer.)

Mr. Fred Barrouk was present on behalf of the Adams County Library requesting that the Township increase funding for 1993 from \$375.00 to \$1,000.00, representing an increase of \$625.00 for 1993 and to consider a donation of \$1,000.00 in the 1994 budget. It is expected that the library is going to fall \$20,000.00 short this year due to reductions in state funding, United Way, etc. After much discussion, Chairman Hilbert asked for more time to consider this request.

Road Report:

Tiles have been repaired on Barlow-Two Taverns Road near Trostle's Furniture Store.

There have been many questions about the surveying work at 15/97. This is part of the venture between the State and the Township to get turning lanes off 97. The project is on schedule, hopefully by spring construction will begin.

Mount Joy Twp. has been doing this; however, there must be a resolution on the books. Before permits are issued a certificate of insurance must be submitted which will be filed with the building permit. Municipality is to issue a "Stop Work" order if certificates are canceled.
