October 8, 1992

The Mount Joy Township Supervisors held their regular monthly meeting on Thursday, October 8, 1992 at 7:30 p.m. in the Township Municipal Building located at 902 Hoffman Home Road, Gettysburg, PA. All members were present.

The minutes of last months meeting were approved by motion of Supervisor Don Moul, 2nd by Supervisor Glenn Snyder, carried.

The Treasurers Report and Bills to be Paid Report, consisting of \$3,756.38 to be paid out of the Payroll Account, checks numbered 1142 through 1152; and \$26,062.92 to be paid out of the General Account, checks numbered 6533 through 6552 were approved by motion of Moul, 2nd by Snyder, carried.

Subdivisions:

-Bob Gitt- Snyder noted that the subdivision meets all setbacks and acreage requirements. The sewer modules seem to be in order. Motion made by Moul to accept the plan per DER approval. 2nd by Snyder, carried.

Road Report:

The Supervisors got prices for line painting from Ross Industries (.05/foot) and Alpha Space (.0325/foot). Alpha Space will paint lines in the Township as well as some roads in Mt. Pleasant Township in order to reach the 10 miles required to receive the lower price.

Correspondence:

Information was received from MetEd concerning the street light on Route 97 and White Road. Resolution No. 92.006 was approved by motion of Snyder, 2nd by Moul, carried.**

At this time Supervisor Moul noted a conversation he had with Barry Hoffman from PennDot concerning the road improvements needed on Route 97 and Heritage Drive. Mr. Hoffman stated that the State would put the top on the road if the township would pay for the base for the passing lanes. The Supervisors will contact PennDot to find out where things stand with the SAMI plan and exactly what the situation is. The largest expense is the engineering work that needs to be done prior to any road work. Hilbert noted that it has been the intention of the Supervisors to make these improvements, and this has been worked on over the past 3 years with attempted negotiations. Mr. Hoffman will be contacted.

- -Letter from the Adams County Board of Assessment Appeals informing us that Roscoe Barnes has resigned his position as assistant assessor for Mount Joy Township and that they are looking for a replacement.
- -Letter from Littlestown Area School District asking that we notify them any time we are closing roads for their bus routes.
- -Information received regarding the Golden Menu Restaurant. The Supervisors will meet with Dean Shultz on October 14 at 1:00 to discuss this problem.
- -DCA Seminars for Hazardous Materials and for winter road maintenance workshops.
- -Letter from Gettysburg National Bank informing us that they are merging with PNC Bank. Old Business:
- -AG District A public meeting will be set up.

-Fuel Tanks - Aero Oil removed the old tanks and found some contamination in the ground. DER will come in to inspect the soils and send a sample to the lab for analysis.

New Business:

- -Jane Lordeman from the YWCA was present to ask for donations for the 1993 year.
- -Budget meeting workshop is scheduled for October 21, 1992 at 2:00 p.m.
- -Rhoda Conover, Tax Collector, asked if the Township would pay for the Tax Collector Convention and for misc. dues. The motion was made by Moul to pay for this year convention but not the dues and to reconsider the convention reimbursement next year, motion 2nd by Snyder, carried.
- -The subject of doing some work at the Pine Bank Cemetery was brought up. It was noted that the township can only spend \$300.00/year on any one cemetery which includes regular maintenance. It didn't get very far. Meeting adjourned at 8:20 p.m.
