

December 14, 1983

The Mt. Joy Township Supervisors held their regular monthly meeting on December 14, 1983 at 7:00 p.m. at the township municipal building on Hoffman Home Road. Harry Hilbert was absent.

The minutes were approved by motion of Glenn Snyder, 2<sup>nd</sup> by Jim Neth, carried.

The treasurer's report was approved by motion of Snyder, 2<sup>nd</sup> by Neth, carried.

John Sanders plans - lots of discrepancies exist on this plan. Send letter to John Morris, P.O. Box 311, Gettysburg, PA 17325 describing what needs to be done to have this plan approved.

Linda Koenig plan - had to reapprove and redate plan.

The 1984 budget was adopted by motion of Jim Neth, 2<sup>nd</sup> by Snyder, carried. The millage was dropped to 4 mills in lieu of 5 mills, \$5.00 per capita tax and ½ of 1% transfer tax.

Front End Loader - 3 models in to demonstrate: John Deer, Case and Caterpillar. Secretary to bid. State that equipment must be United States made. Discussed in detail specifications the supervisors will require in this loader. All will be minimum specifications. Bids to be opened at reorganization meeting January 2, 1984 at 7:00 p.m.

Letter read from LHMA solicitor about sewage sludge. This will not effect portion on or township.

Gypsy Moth Program- Township has 260 available acres, at \$1.00 per acre. Must be paid by January 20, 1984 in order to participate. There was some question on acreages of several persons. Neth made a motion to pay for this spraying, 2<sup>nd</sup> by Snyder, carried.

Letter read from Littlestown Sr. Center thanking township for contribution.

Revenue Sharing has been reinstated. This will amount to basically the same as previous years. 33.5 miles of township road (1100 per mile)

2.8 miles of state roads (2,500. Per mile)

Estimate to clean floors in township meeting room from Lightner's Floor Service - Clean, wax and buff - \$28.00

Cleaning and stripping - \$78.00

Supervisors decided to go ahead with this project.

Salt for ice removal \$85 to \$90 per ton.

Calcium - \$140 to 150 per ton.

Meeting adjourned at 9:09 p.m. by motion of Neth, 2<sup>nd</sup> by Snyder, carried.
