

November 13, 1990

The Mount Joy Township held their regular monthly meeting on Thursday, November 13, 1990 at 7:30 p.m. at the Township Municipal Building on Hoffman Home Road. All members were present.

The minutes of the October meeting were approved by motion of Glenn Snyder, 2<sup>nd</sup> by Wilbur Danner, carried. The Treasurer's report and the Bills to be paid report, consisting of \$4,908.61, checks numbered 6026 through 6040 to be paid out of the General Account; and \$2,986.09, checks numbered 979 through 986 to be paid out of the Payroll Account, were approved by motion of Snyder, 2<sup>nd</sup> by Danner, carried.

Old Business:

-Subdivision of John and Hazel Vockroth - The motion was made by Snyder, 2<sup>nd</sup> by Danner, to accept the plan presented to the Board subject to DER approval. Motion carried.

-Subdivision of Jim Williams - White Run Subdivision - All requests from the board as of the meeting on October 11, 1990 have been met by Mr. Williams. The motion was made by Harry Hilbert to approve the subdivision as presented. 2<sup>nd</sup> by Danner. It should be noted that the Mount Joy Township Planning Commission did not approve of the "Pie-Shaped" lots, namely lots #12 and 13. This was not noted in writing to Mr. Williams until a letter dated October 30, 1990. The Supervisors approved the plan without the Planning Commissions approval. Motion carried.

New Business:

-1991 Budget - Motion made by Snyder, 2<sup>nd</sup> by Danner, to put the proposed budget up for review until the meeting on December 13, 1990, when it will be approved. Motion carried.

Correspondence:

-Letter from DER concerning a change in the way sand mound systems are installed. Our engineer is aware of this change.

-Letter from DER concerning Water Well Drilling Regulations.

-Letter announcing Recycling Training Seminar

-Letter from PA Classic Cable noting a rate increase from \$14.95 per month to \$15.95 per month.

-Letter from PSATS concerning the nominations for Outstanding Township leader for 1990.

-Letter from Adams County Commissioners announcing the meeting concerning the Comprehensive Plan on November 15, 1990 at 1:30 p.m. in the Old Court House. It was decided that Snyder and Hilbert would attend.

-Box Culverts should be delivered this week. Will start work as soon as the weather cooperates.

-Zoning: All of the changes that our board made are now in the hands of URDC. They will put together a program and the meeting will be announced.
