RESOLUTION NO. 17 OF 2020

TOWNSHIP OF MOUNT JOY, ADAMS COUNTY, PENNSYLVANIA

A RESOLUTION OF THE TOWNSHIP OF MOUNT JOY, ADAMS COUNTY, PENNSYLVANIA, ESTABLISHING A PROCEDURE TO DISPOSE OF PERSONAL PROPERTY OF THE TOWNSHIP HAVING INDIVIDUAL AND AGGREGATE VALUES OF LESS THAN TWO THOUSAND DOLLARS (\$2,000.00)

WHEREAS, from time to time the Township has items of personal property that it no longer needs or desires to retain; and

WHEREAS, Section 66504 of the Second Class Township Code, 53 P.S. §66504, enables the Township to dispose of personal property having a fair market value of less than \$2,000.00; and

WHEREAS, with respect to the disposition of personal property having a fair market value of less than \$2000.00, Section 66504 requires that the Board of Supervisors establish by resolution a procedure for the disposition of such property without further formal action;

WHEREAS, by Resolution 2000-0217 the Board of Supervisors, in accordance with then current law, previously provided for disposition of private property having a value of less than \$1000.00:

WHEREAS, the Board of Supervisors resolves to provide a procedure for the disposition of property having a fair market value as currently established by Section 66504 or as Section 66504 may be amended from time to time;

NOW BE IT RESOLVED by the Board of Supervisors that personal property having a fair market value of less than \$2,000.00 (or the value established by Section 66504 as it may be amended from time to time), which is no longer needed by the Township and is no longer desired to be retained by the Township, may by determination and under the direction of the Chairman of the Board of Supervisors be disposed of through any lawful means including advertisement,

direct sale, or public auction. The Board shall be informed in writing of the sale of such property at its next regular meeting following the sale, including (i) identification of the property, (ii) information/sources considered to determine its fair market value, (iii) manner of sale, (iv) date of sale, and (v) sale proceeds. The proceeds of such sale, less the costs of sale, shall promptly be turned over to the Township Treasurer.

BE IT FURTHER RESOLVED by the Board of Supervisors that Resolution 1000-0217 is hereby repealed.
