

NOVEMBER 20, 2003 PUBLIC HEARING – TOWNSHIP CODE ADOPTION:

The Mount Joy Township Board of Supervisors held a Public Hearing at 6:30 p.m. this date, as publicly advertised, at the Mount Joy Township Municipal Building, 902 Hoffman Home Road, Gettysburg, PA 17325, with Board Chairman James W. Waybright presiding. Others in attendance were: Supervisors William Chantelau, George Scott, William Rogers, and Harold Kirschner; and Secretary Brenda J. Constable. Citizens in attendance were: Raymond Boyd.

Purpose of Hearing:

Mr. Waybright stated that the purpose of this hearing is to give an opportunity for any interested persons to give comment on the proposed Code Adoption Ordinance, for re-approval, adoption, and enactment of the codification of a complete body of legislation for Mount Joy Township. This codification is known as "The Code of the township of Mount Joy" and was originally accepted in 1996 but the original adopted ordinance was either lost or misplaced. He noted that a summary of this Ordinance was publicly advertised in *The Gettysburg Times*. Mr. Waybright stated that it is the intent of the Supervisors to adopt this Ordinance at the Supervisors' regular meeting beginning at 7:00 p.m. this date.

NOVEMBER 20, 2003 PUBLIC HEARING – ACT 537 SEWAGE FACILITIES PLAN:
