The Secretary is to publish the following legal notices.

- I. The Board of Supervisors of Mt. Joy Twp., Adams Co., Pa. hereby give notice that they will not be responsible for any Bills or claims or damage or liabilities, not authorized by the Board of Supervisors for the year 1962.
- II. The Board of Supervisors, has re-enacted without substantial change the Resolution pertaining the per capita ax of \$5.00 on adult residents of Mt. Joy Twp. for the year 1963.
- III. The 1956 Resolution which provides for the assessing, levying and collection of Real Estate Transfer ax of 1% for General Revenue Purposes, has been re-enacted without substantial change for the year 1963 by the Supervisors of Mt. Joy Township.

The Supervisors agreed and approved that the (money's) received from Fines and Real Estate Transfer Tax, during the year 1963, will be put into the Equipment Fund along with the (2) mills from Real Estate Taxes for equipment fund purposes.
