

February 2, 1961

The Supervisors of Mt. Joy Twp., Adams Co., Pa. held their regular monthly meeting at the house of the Secretary instead of the election home as scheduled due to bad weather at 6:30 p.m. February 2, 1961.

All members were present—The minutes were read and approved.

It was brought to the attention of Supervisors by Mr. Rex Maddox that the Supervisors authorize Wilson Clapsaddle to maintain equipment to keep roads opened around Wolf Hill to remove snow. The matter has been discussed among the Supervisors and the said Supervisors do not approve such action.

The Secretary was authorized to advertise, by all members of the Board, for sealed Bids for stone for said Township for the year 1961. Bids due to be opened march 2, 1961 at 7:30 p.m. EST in the Township Election House.

The Secretary was also authorized to publish the following Legal Notices in a local paper:

1. The Board of Supervisors of Mt. Joy Township, Adams Co., Pa. hereby give notice that they will not be responsible for any bills, or claims or damage or liabilities, not authorized by the Board of Supervisors for the year 1961.
2. The Board of Supervisors, has re-enacted without substantial change the resolution pertaining the per capita tax of \$5.00 on adult residents of Mt. Joy Twp. for the year 1961.
3. The 1956 resolution which provides for the assessing, levying and collection of a realty Transfer tax for general revenue purposes; has been re-enacted without substantial change for year 1961 by the Supervisors of Mt. Joy Twp.
