The Supervisors of Mt. Joy Township, Adams Co., Pa. held their regular monthly meeting for February on February 3, 1978 at 7:00 p.m. in the Election House, Two Taverns, Pa. All members were present. The minutes were read and approved.

The supervisors approved subdivision plans for Bruce Crouse and also William H. Scott.

Two Supervisors from Cumberland Township, Mr. Howard Waybright and Francis Weikert were present to ask the Supervisors of Mt. Joy Township with their permission to vacate approximately .2 miles of Township Road (Benner Road) in Cumberland Twp., due to not being used. Permission was granted by the Supervisors for record purposes.
