

April 11, 1980

The Mt. Joy Township Supervisors held their regular monthly meeting on Friday April 1, 1980 at 7:00 p.m. at the township municipal building on Hoffman Home Road. All members were present.

The minutes were approved by motion of Glenn Snyder, 2nd by Jim Neth, carried.

The treasurer's report was approved by motion of Snyder, 2nd by Neth, carried.

A motion was made by Snyder to pay all bills as they appear on the treasurer's report, 2nd by Neth, carried.

Attorney Mark David Francel spoke representing the people of the township who do not want a Junk Yard Ordinance. He told the people about four (4) things that he and the Supervisors and their solicitor, Sam Teeter, discussed prior to the meeting.

1. New Ordinance-Supervisors just received a copy of the revised ordinance today.
2. Table for 60 days-so that people and their attorney can discuss
3. May purchase copy-of new ordinance at home of township secretary for \$1.00
4. Three (3) member grievance committee of people to discuss ordinance and supervisors.

There was quite a lot of discussion about the ordinance, including a few comments from Ken Cole who said in general that the people must keep their heads and work for the best of the township. He said he hopes the Supervisors can come up with something that we can all live with. He has some suggestions and will send them to Sam Teeter.

After quite a lot of hassle a motion was made by Neth to table the ordinance for 60 days, 2nd by Snyder, carried.

A letter was read from Penn Dot about roads. They would like the township to take over some state roads and would reimburse township so much per mile. Supervisors said if roads would be in good condition this would be O.K. but at the present Supervisors feel the answer to this would be no.

Citizens along Route 97 between Rock Creek and Lake Heritage entrance are complaining about speed limit in this area. A child was hit by a car some time ago and hence a petition has been circulated in the area about lowering the speed limit to 45 m.p.h. a motion was made by Neth to give this petition to Representative Ken Cole, 2nd by Snyder, carried. Neth will do so.

A Ms. Schultz (lives in trailer) along Cemetery Road is complaining about parties going on and excessive noises (loud mufflers, etc.) on this road. State police say go to the Supervisors and have them put up signs (Example: Road closed between such and such hours) This is a public road and supervisors can't put up such signs.

Who is responsible for taking care of cemetery on Cemetery Road? Landowners. Who are they? Check records probably at York.

Mr. Cober is concerned about muddy well water. DER is aware of this problem and supervisors are going to check into this situation.

Lake Heritage Property Owners Association would like a resolution from township that we send them a copy of a building permit to L.H.P.O.A.. Supervisors authorized Sam Teeter to write letter to L.H concerning this matter.

Supervisors check trees along White Church Road.

Also check tile at Steve Kelley's at Clapsaddle Road (could it be lowered?)

Next meeting will be held on Friday May 9, 1980 at 7:30 p.m.

Meeting adjourned at 8:55 p.m. by motion of Neth, 2nd by Snyder, carried.
