

May 11, 1983

The Mt. Joy Township Supervisors held their regular monthly meeting on Wednesday, May 11, 1983 at 7:30 p.m. at the township municipal building on Hoffman Home Road. All members were present.

The minutes were approved as presented by motion of Glenn Snyder, 2<sup>nd</sup> by Harry Hilbert, carried.

The treasurer's report and bills to be paid were approved by motion of Snyder, 2<sup>nd</sup> by Hilbert, carried.

Secretary reported that she closed savings accounts at Adams County National Bank and Community National Bank and opened money market accounts.

Bids were opened at 7:30 p.m. and were as follows:

Wilson Paving - FB1 Wearing - \$25.20 per ton = \$45,360.00

Bid was awarded to Roadite by motion of Hilbert, 2<sup>nd</sup> by Neth, carried.

The plans from King Investment to Fred Straley were approved by motion of Snyder, 2<sup>nd</sup> by Neth, carried.

The Verna Schwartz plans were approved by motion of Snyder, 2<sup>nd</sup> by Hilbert, carried.

Workman's Compensation - Snyder and Hilbert reported on the meeting they had with the Cumberland Township Supervisors. Cumberland did house count and came up with 1017 people which according to them would cost Mt. Joy township \$890.00- this is excessive! According to Skip Hockley, our agent, the correct way of doing this is to piggy-back on to their present policy. To do so would cost Mt. Joy Township \$370.00. Cumberland also gets a dividend back at the end of the year which amounts to 28%. Cumberland said they want \$750.00, no dividend for Mt. Joy or they will continue to pay as they have been doing. Supervisors discussed this matter and agreed to pay \$370. To Cumberland for additional population. If the check is cashed, this means they have accepted, if not we will no doubt hear from them. This motion was made by Snyder, 2<sup>nd</sup> by Neth, carried. Secretary wrote check and paid bill.

County Aid to be received this year is \$2,835.60. Supervisors designated to finish King Road with County Aid monies.

Germany Township wants to rent our mower and our man to operate the mower. Supervisors agreed to this at a rate of 25.00 per hour.

Meeting adjourned at 9:15 p.m. by motion of Neth, 2<sup>nd</sup> by Hilbert, carried.
