The Board signed project Agreement Form 972 for using Balance of 1955 State Matching Money for roads described in March 2<sup>nd</sup> meeting minutes.

The Supervisors set aside from Twp. fund \$2,948.41 as their share for these roads. Funds for matching money was set up under Budget 35 to pay for it.

These forms are to be sent to the Dept. of Highway, Twp., Unit for approval.

The Board order Sec. to write to Gray concrete pipe Co., Inc., Hagerstown, Md. for prices on culvert pipe. Earthmoving, Inc., Gettysburg, Penna. for quotations and prices for road equipment.

The Board received an approved copy of project Agreement NO. 7234 setting aside \$2,948.11 of our municipality. Allocation of State Matching Funds for the improvement of Roads No. 412, 413, 424 and upon completion of this project, we are to notify our local District Twp. Engineer of the Department of Highways.

The work on this project will commence on or about July 1. 1956.

The Board voted the repair windows and switch Election house and hire a repairman to do it.
