

June 8, 1989

The Mt. Joy Township Supervisors held their regular monthly meeting on Thursday June 8, 1989 at 7:30 at the township municipal building on Hoffman Home Road. All members were present.

The minutes were approved with the addition of Steve Kelly's name added to the minutes stating that he had complained about Charlie Davies junk yard.

The minutes were then approved by motion of Glenn Snyder, 2nd by Harry Hilbert, carried.

The treasurer's report was approved by motion of Snyder, 2nd by Wilbur Danner, carried. Approval was given to pay the electric bill which had just come in the mail this date.

Bids were opened for FB1 and were as follows:

Roadite - 2,500 tons Binder \$19.77

6,500 tons Wearing \$22.13 for a total of \$193,270

Hammaker - 2,500 tons Binder \$18.88

6,500 tons Wearing \$22.33 for total of \$192,345.

The bid was awarded to Hammaker by motion of Hilbert, 2nd by Danner, carried.

The sub-division of George Sentz property was approved by motion of Danner, 2nd by Hilbert, carried.

Dump Truck bid was opened June 6, 1989. Bid was specifications \$42,499 with trade; or \$44,599 without trade. The alternate bid was \$42,092 with trade; or \$44,192 without trade. Supervisors decided to award bid to Sheets Brothers Truck in Hanover for the bid as specs called for. Supervisors believe maybe they can see the old truck before the new one arrives for more money than the shows. If not, the truck will be traded. The motion was made by Danner, 2nd by Hilbert, carried.

Erma Shields of Lake Heritage complained about sewer from the next door neighbor running onto her property. Supervisors to check this out.

Junk yard - Kelly stated that Mr. Davies has not cleaned up along the road. He is still dragging cars across the road. Supervisors to have solicitor write a letter to Mr. Davies telling him to come into compliance with the ordinance.
