

May 13, 1977

The Supervisors of Mt. Joy Township, Adams Co., Pa. held their regular meeting for May on May 13, 1977 at 7:00 p.m. instead of May 6, the regular time and date. All members were present. The minutes were read and approved.

Mr. Milburn J. Harris, resident of Mt. Joy Township was present at the meeting to advise the supervisors of the legal action being taken against the Board in which the Board has filed a complaint by Mr. Harris by closing a drain tile which carries field drainage. Hearing to be on May 23, 1977 at 2:30 p.m. at the office of the Justice of the Peace, Eugene Long. Mr. Harris called the Supervisors incompetent and threatened Mr. Waybright and told him he had better not step one foot on his property. Mr. Harris was told that the matter is now out of the Supervisors hands and any comment will be made at the hearing.

Mr. Clarence Williams was present at the meeting in regards to a complaint that has been lodged by taxpayers in which Mr. Williams (they claim) of having used auto and trucks on his property. Mr. Williams advised the Supervisors he is cleaning up the property and he stated that all the vehicles on his property are licensed. No action was taken at this time.

An ordinance in which the Supervisors were asked to pass was presented in the form of a resolution was presented to the Township, pertaining to Holding Tanks at Lake Heritage. Action was not taken at this time until the solicitor of the Township has ample time to stud the resolution.

A motion was made by Willis Waybright and seconded by Wilbur Danner to except the proposal by Geo. Strevig to install a pump and all labor to the well just recently dug for the Township.

A motion was made for the Treasurer to pay township Bills by Clarence H. Myers and seconded by Wilbur Danner.
