

August 8, 1984

The Mt. Joy Township Supervisors held their regular monthly meeting on Wednesday August 8, 1984 at 7:30 p.m. at the township municipal building on Hoffman Home Road. All members were present.

The minutes were approved by motion of Glenn Snyder, 2<sup>nd</sup> by Jim Neth, carried.

The treasurer's report was approved by motion of Neth, 2<sup>nd</sup> by Snyder, carried.

The plans of Pham Xuam Chieu were approved subject to approval of sewage module by DER. Motion made by Neth, 2<sup>nd</sup> by Snyder, carried.

The tile on the Ken Dehoff property was checked by the sewage enforcement officer and Snyder. Shultz did grade on this area. The spillway is 6" lower than the upper side of the pond. Snyder called Mr. Dehoff and explained the problem to him and he seemed to understand. Snyder suggested that the township build bank at lowest point and Mr. Dehoff agreed. Township will level and seed bank. Legal papers to be drawn up by solicitor releasing township from any damages (or what have you) that Mr. Dehoff might seek after the work is finished.

LHMA application for sludge received by DER for Dayhoff farms.

David and Debra Coll - LHMA denied request for a holding tank. Will have hearing on this. Dispute between DER and lot owners, not township.

Diane Frock - Secretary sent letter to McQuaide stating that no changes must be made on this. Ms. Black from McQuaide's office contacted secretary and sent letter for supervisors to sign reapproving this property. Neth made a motion to sign letter reapproving the Frock property, 2<sup>nd</sup> by Snyder, carried.

Hansford property - Snyder made a motion to deny Bud Hansford permission to use trailer for dwelling, not enough ground, 2<sup>nd</sup> by Harry Hilbert, carried. Snyder to contact Dean Shultz advising him to NOT issue a permit to Hansford.

Davies - On July 17, 1984 the Supreme Court entered its order denying the petition for allowance of appeal filed in this case. Township has prevailed.

All roads done except Solomon Road - will be back in about a month to put tops on. Long Road - fixed up from Orphanage Woods to end.

Gypsy Moth Program for 1985 - A motion to participate in this program was made by Neth, 2<sup>nd</sup> by Hilbert, carried.

House Bill 1385, Health Insurance - State association to backing this bill, will be receiving more information. on this.

Mr. Jack Harris of Roberts Road is having problems again. Mr. Harris has filled the natural waterway with ground at the point where he concreted the tile shut a few years ago. Township does not know at this point what problem may arise later. Snyder to contact soil conservation office about shooting a grade there.

Meeting adjourned at 9:15 p.m. by motion of Neth, 2<sup>nd</sup> by Snyder, carried.
