## AGREEMENT FOR BICYCLE EVENTS USING TOWNSHIP ROADS

WHEREAS, the Township owns and maintains public roads; and

**WHEREAS**, the safe use of the roads includes the erection and maintenance or lawful, necessary and proper road signage and markings by the Township; and

WHEREAS, \_\_\_\_\_\_ desires to use the Township roads for the conduct of an organized private bicycle event known as \_\_\_\_\_ and to be held \_\_\_\_\_\_ utilizing \_\_\_\_\_\_ in the Township; and

**WHEREAS**, \_\_\_\_\_\_ and the Township mutually intend to memorialize certain terms for the use of the public roads for the identified event.

**NOW THEREFORE**, in consideration of mutual promises contained herein and intending to be legally bound hereby, the parties agree as follows

1. \_\_\_\_\_\_ expressly acknowledges and agrees, at its sole cost and expense, to the following terms:

- a. For purposes of this Agreement "directional signage" includes signs, balloons or other device intended to attract a cyclist's attention and inform the cyclist of the event route.
- b. No directional signage may be posted in a public right-of-way nor markings affixed to the public road unless the Township is given 10 calendar days written notice identifying the event and the event sponsor(s), stating the anticipated number of participants, and describing in detail the event route in the Township.

- c. Any directional signage posted in a public right-of-way shall be placed no earlier than 24 hours prior to the start of the event and shall be removed within 24 hours of the completion of the event.
- d. No directional signage shall be placed in the public right-of-way in such manner as would interfere with the safety of the motoring public or which would otherwise distract the motoring public. No directional signage shall be attached to any official road sign. No directional signage shall be placed within 15 feet of a stop sign or other warning or safety sign.
- e. Any directional markings affixed to a roadway shall be affixed only with chalk, water soluble paint or removable tape. If taped, the tape shall be removed from the roadway within 24 hours of the completion of the event.
- f. A motorized vehicle associated with the management of or participant in the event shall not be parked on any part of the paved area of a Township road and shall not be parked closer than 15 feet from a stop sign or other warning or safety sign.

2. The parties agree and understand that the provisions of this Agreement do not impose on the Township any obligations, except as specifically stated herein.
