Revised Fee Schedule for Sewage Facilities

A RESOLUTION REVISING THE FEE SCHEDULE FOR ADMINISTRATION FOR THE SEWAGE FACILITIES ACT (ACT 537) AND APPOINTING DEAN A. SHULTZ AND EDWARD L. MORT AS SEWAGE ENFORCING OFFICERS FOR MT. JOY TOWNSHIP FOR 1976.

Now then therefore be it resolved by the Board of Supervisors of Mt. Joy Township that in a stated meeting on this 4th day of February 1976 do hereby appoint Dean A. Shultz and Edward L. Mort as Sewage Enforcing Officers for the year 1976.

And further be it resolved that the fee schedule for the administration of the Penna. Sewage Facilities Act (Act 537) be revised as and adopted as following:

- I. Application Fee for all new systems-----\$40.00
 - (a) This fee entitles the applicant to a site investigation, test pit analysis (maximum of two per lot) certification of percolation tests (if required) and the office processing of that application.
 - (b) Any evaluation requiring additional field investigations beyond the initial visits to the site stipulated above will require the following fees:
 - (1) For each additional visit to the site-----\$12.50
 - (2) For each additional test pit over two-----\$7.50
 - (c) If the test pit is not dug when Sewage Enforcing Officer is notified to inspect site, or percolation tests are to be re-conducted, the applicant will pay the fee for an additional visit to the site.

- II. Permit Fee for all single family residents utilizing a conventional system-----\$10.00
- 3. Permit Fee for all single family residents utilizing an elevated sand mound-----\$20.00
- 4. Permit Fee for all multi-family, commercial, institutional or other applications will be based on the size of the sub-surface disposal system.
 - Conventional System
 - (a) 150 sq. ft. to 1000 sq. ft. ----- \$10.00
 - (b) 1000 sq. ft. to 2500 sq. ft. ----- \$20.00
 - (c) 2500 sq. ft. to 5000 sq. ft ----- \$40.00
 - (d) 5000 sq. ft. to 10,000 sq. ft. ----- \$75.00

 - Alternate System
 - (a) 150 sq. ft. to 1000 sq. ft. ----- \$20.00
 - (b) 1000 sq. ft. to 2500 sq. ft. ----- \$40.00
 - (c) 2500 sq. ft. to 5000 sq. ft. ----- \$75.00
 - (d) 5000 sq. ft. to 10,000 sq. ft. ----- \$125.00

Any disposal area size over 10,000 sq. ft. will require fees commensurate with work performed as determined by the municipality.

V. Inspection Fees

Conventional System: The cost of final inspection is included in the permit fee. If the system is not ready for inspection when notified or corrections must be made, a fee of \$12.50 will be charged for each additional trip to the site.

Alternate Systems: Inspections of alternate systems will require fees commensurate with work performed on an hourly basis-----\$7.50 per hr.

Said fee will be billed by the Township to the applicant and must be paid before final approval is given.

VI. Transfer of application and permit -----\$35.00

7. Alternations to existing systems not requiring soil tests -----\$25.00

8. Fee for review of Act 537 Official Plan, Revisions and Supplements will be \$5.00 per lot for subdivisions from one to ten lots. For all other reviews of larger developments, commercial, institutional, and other applications will require fees commensurate with work performed as determined by the municipality.

Said fees must be paid before any inspections or work can be performed.
