Tax Levying and Appropriations

Resolution No. One.

A resolution of the Township of Mt. Joy Township, Adams County of Pennsylvania, fixing the tax rate and special levies for the fiscal year ending December 31, 1957, and appropriating specific sums estimated to be required for the specific purposes of the Township, hereinafter set forth during the current fiscal year. Be it resolved and enacted, and it is hereby resolved and enacted by the Board of Supervisors of the Township of Mt. Joy, Adams County of Pennsylvania.

Section I. That a tax be and the same is hereby levied on all property and occupations within the said Township subject to taxation for Township purposes for the fiscal year ending December 31, 1957, as follows:

Tax rate, for general township and road purposes, the sum of five (5) mills on each dollar of assessed valuation or the sum of fifty (.50) cents on each one hundred dollars of assessed valuation for debt purposes, the sum of \_\_\_\_ mills on each dollar of assessed valuation or the sum of \_\_\_\_\_ cents on each one hundred dollars of assessed valuation.

Section II. That for the special purposes for which the supervisors of said Township are authorized by law to levy and collect taxes, rates are hereby levied for the fiscal year ending December 31, 1957, in amount and for specific purposes as follows.

Tax Rate, for general township and road purposes the sum of five dollars (\$5.00) per capita tax levied on 771 taxables of said township.

Tax rate for special equipment fund, the sum of one (1) mill on each one hundred dollars of assessed valuation.

Section III. That for the expenses of the Township for the fiscal year ending December 31, 1957 the following amounts are hereby appropriated from the revenues available for the fiscal year for the specific purposes set forth below, which amounts are more fully itemized in preceding pages of this Budget.

Resolution No. Two

Providing for the imposing levying, assessing and collection of a tax for General Revenue purposes for the Board of Supervisors of Mt. Joy Twp. Adams County, Pennsylvania, upon deeds and like instruments which convey and transfer lands or any interest therein, situate wholly or in part within Mt. Joy Twp. aforesaid.

Conferring powers upon the Recorder of Deeds of Adams County aforesaid, and other persons, providing for the payment of said tax: prescribing the manner and method of Collection of the Tax imposed, Levied and assessed by this Resolution: Granting certain exemptions and imposing penalties: as further explained in proof of publication.

That for the expenses of the Township for the fiscal year ending December 31, 1957, from the Revenues available for the fiscal year for the specific purposes set forth below, which amounts are more fully itemized in preceding page of Budget.
