A RESOLUTION REVISING MT. JOY TOWNSHIP'S "ACT 537" SEWER AND WATER PLAN TO INCLUDE THE INSTALLATION OF A PACKAGE SEWAGE TREATMENT PLANT ON A PORTION OF THE WILLIAM MARTIN FARM ALONG WHITE CHURCH ROAD, SAID PLANT TO BE OPERATED AND MAINTAINED BY LAKE HERITAGE MUNICIPAL AUTHORITY AND TEMPORARILY USED TO TREAT THE SEWAGE FROM HOLDING TANKS WITHIN THE AUTHORITY'S JURISDICTION AND ALSO USED TO TREAT THE SEWAGE FOR HOMES IN THE PROPOSED DEVELOPMENT OF WILLIAM MARTIN.

WHEREAS, Section 5 of the Act of January 24, 1966, P.L. 1535, No. 537, known as the "Pennsylvania Sewage Facilities Act", as amended, and the Rules and Regulations of the Pennsylvania Department of Environmental Resources (Department) adopted thereunder, Chapter 71 of Title 25 of the Pennsylvania Code, require Mt. Joy Township to adopt an Official Sewage Facilities Plan for the provision of adequate sewerage systems and to revise said plan from time to time as may be necessary, and

WHEREAS, Lake Heritage Municipal Authority, an Authority appointed by the townships of Mt. Joy, Straban, and Mt. Pleasant to provide sewage service to Lake Heritage and the surrounding area, intends to construct a package treatment plant to treat the sewage from existing and proposed holding tanks within their jurisdiction and to also provide service to a planned development of William Martin adjacent to the proposed Sewage Treatment Plant, until the proposed regional sewage system is in operation, and

WHEREAS, said Sewage Treatment Plant will be located on a portion of ground being leased from the farm of William Martin along White Church Road, and

WHEREAS, a Revision to Mt. Joy Township Act 537 Plan has been prepared by Gannett, Fleming, Corrdry and Carpenter, consulting engineers for the Lake Heritage Municipal Authority, and

WHEREAS, said plan has been reviewed by the Mt. Joy Township Supervisors and the Adams County Planning Director and has been found acceptable;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Mt. Joy Township, Adams County, Pennsylvania, at their meeting held on the \_\_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 1977, that the above mentioned proposed revision to Mt. Joy Township's "Act 537 Plan" be approved on the condition that this plant be abandoned when the proposed regional sewage treatment system is in operation, and

FURTHER BE IT RESOLVED that 4 copies of this resolution be submitted to the Department of Environmental Resources for its review and approval.
