MINUTES APRIL 13, 2022 SPECIAL MEETING

A PUBLIC HEARING ON BROOKVIEW PRELIMINARY LAND DEVELOPMENT PLAN ALSO WAS HELD ON THIS DAY.

The meeting was an open meeting, also conducted as a remote meeting through the ZOOM platform. Attendance and votes were taken by roll call.

Special Meeting

Special Meeting opened at 7:00pm

Chairman Mazer made comments before opening the scheduled public hearing on the Brookview Preliminary Land Development Plan. He stated that the Board of Supervisors of Mount Joy Township, Adams County, Pennsylvania, will conduct a public hearing to inform and obtain public comment on the Plan prior to taking action on the Plan in accordance with Section 508 of the Pennsylvania Municipalities Planning Code.

Solicitor Smith said that the MPC permits a public hearing on a land development plan but does not require it. She noted that the public hearing is limited to the Plan. She explained this public hearing is different from a quasi-judicial hearing as was held on the Brookview conditional use. There will be no parties, witnesses, or exhibits. She also indicated that there is a stenographer present solely to transcribe the audio portion of the meeting. So that there is a transcript. Any documents should be submitted to the Board and to the Secretary. This is not a conditional use. The public hearing is to received public comment on the pending preliminary land development plan. She explained that the applicant will make a presentation on the Plan and the Board will allow questions to the applicant related to the plan. The Board will then open up the public hearing for public comment.

Chairman Mazer repeated that this public hearing is not required. This is the first time there has ever been a public hearing like this. The Board operates in 3 capacities. They make rules, act in quasi-judicial matters and administrative matters. The Board will not be taking any action tonight. Action on the land development plan will occur at another time. Chairman Mazer explained that Brookview will start with their presentation followed by questions and answers from the public on the Plan. After Brookview's presentation, the public is invited to make public comments.
