RESOLUTION NO. 14 OF 2015

A RESOLUTION OF THE BOARD OF SUPERVISORS OF MOUNT JOY TOWNSHIP, ADAMS COUNTY, PENNSYLVANIA, AUTHORIZING CHAIRMAN OF THE BOARD OF SUPERVISORS TO EXECUTE CERTAIN STORMWATER MANAGEMENT AGREEMENTS WITHOUT PRIOR BOARD OF SUPERVISORS APPROVAL

WHEREAS, Chapter 81 Stormwater Management of the Code of the Township of Mount Joy provides for the management of stormwater relating to development in the Township; and

WHEREAS, Chapter 81, Section 81-502, requires an operation and maintenance agreement for stormwater management facilities required and approved as part of a stormwater management site plan for a development; and

WHEREAS, the stormwater management site plans subject to such agreements are submitted to Township Engineer for review and approval and the Township Engineer subsequently inspects the stormwater management facilities constructed in accordance with the approved stormwater management site plans; and

WHEREAS, the stormwater management operation and maintenance agreements require official action by the Board of Supervisors as a party to the agreements; and

WHEREAS, in consideration of the technical subject of stormwater management operation and maintenance agreements, the related stormwater management site plans, and inspection of related stormwater management facilities by the Township Engineer, the Board of Supervisors believe appropriate administrative efficiencies can be achieved in the administration of Chapter 81 through alternate procedures for action upon certain stormwater management operation and maintenance agreements required by Chapter 81.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF MOUNT JOY TOWNSHIP:

The Chairman of the Board of Supervisors is authorized to execute, on behalf of the Board of Supervisors, the stormwater management operation and maintenance agreements described below.

To the extent a project does not otherwise involve commercial use or subdivision and/or land development plan approval:

1. Level 3 stormwater management site plans for projects associated with single family residential uses or agricultural uses, such a single-family residential structure or addition thereto, driveways, garages, and accessory buildings.

2. Level 4 stormwater management site plans for projects associated with single family residential uses or agricultural uses, such as a single family residential structure or addition thereto, driveways, garages and accessory buildings.

Provided, that:

- a. The Township Engineer has issued an approval letter following review of the stormwater management site plan.
- b. The Township Solicitor has reviewed and counseled approval of the stormwater management operation and maintenance agreement.

The Board of Supervisors shall be informed of any and all agreements executed by the Chairman, under the authority provided by this Resolution, no later than the Board of Supervisors' regular meeting following the date of execution.
