RESOLUTION NO. 15 of 2005

## A RESOLUTION

OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF MOUNT JOY, ADAMS COUNTY, PENNSYLVANIA AUTHORIZING AND EMPOWERING THE YORK ADAMS TAX BUREAU TO IMPOSE AND RETAIN THOSE COSTS AND FEES ASSOCIATED WITH THE COLLECTION OF DELINQUENT TAXES IN ACCORDANCE WITH ACT 192 OF 2004.

ADOPTED DECEMBER 20, 2005

WHEREAS, The Township of Mount Joy, (the "Township") is a township of the second class and a political subdivision of the Commonwealth of Pennsylvania (the "Commonwealth") located within the geographical boundaries of the County of Adams (the "County"); and

WHEREAS, The Governing Body of the Township, by Resolution and/or Ordinance, has levied, assessed and provided for the collection of certain local taxes under and pursuant to the authority of Act No. 511 of the 1965 General Assembly of the Commonwealth of Pennsylvania, enacted December 31, 1965, and effective January 1, 1966, as amended; and

WHEREAS, the Governing Body of the Township, by Ordinance No. 2005-12, has levied, assessed and provided for the collection of certain local taxes under and pursuant to Act 511 of the 1965 General Assembly of the Commonwealth of Pennsylvania, enacted December 31, 1965, and effective January 1, 1966, as amended; and

WHEREAS, The Governing Body of the Township has designated the York Adams Tax Bureau to collect said taxes levied by the Township, including taxes levied by the Township, including taxes that are or may become delinquent; and

WHEREAS, pursuant to Act 192 of 2004, the Governing Body of the Township, or its designated tax collector of the aforementioned local taxes, is entitled to impose and retain those costs of collection on taxes that become delinquent and/or that remain due and unpaid.

## NOW, THEREFORE, BE IT SO RESOLVED THAT:

- 1. The Governing Body of the Township hereby approves and adopts the Cost of Collection Schedule, attached hereto and made a part hereof, to be imposed by the York Adams Tax Bureau, or such other tax collection entity hereafter designated by the Governing Body of the Township for the collection of local taxes, upon any taxpayer whose taxes are or become delinquent and/or remain due and unpaid. Said fee schedule may be amended from time to time by resolution of the Township.
- 2. The York Adams Tax Bureau, or such other tax collection entity, designated by the Governing Body of the Township, is authorized to retain such costs of collection as set forth in the attached schedule in recovering delinquent taxes and as permitted to be assessed to delinquent taxpayers pursuant to law.
- 3. Any resolution or part thereof conflicting with the provisions of this Ordinance is hereby repealed to the extent of such conflict.
- 4. This Resolution shall be effective immediately upon its adoption by, at least, a majority of the members of the Governing Body of the Township.
