**§110-109. Swimming pool, household or private.**

- A. A proper method shall be provided for drainage of the water from the pool that will not overload or flood any on lot septic system or any basement of any building.**
- B. The pool shall not involve any commercial use.**
- C. The accessory structure setback requirements shall apply not only to the area of water, but also to any deck or patio that is elevated above the ground level.**
- D. Any man-made swimming pool with a water depth of greater than two feet shall be completely surrounded by a secure fence with a minimum height of four feet or by the sides of an above-ground pool with a minimum height of four feet. Such fence shall include a self-latching gate.**
- E. Any inlet from a public water system shall be above the overflow level of the pool.**

**Pools in excess of 24 feet must be inspected.**

**In-ground pools 30 feet from wells**
