### **Business:**

• Whitney J. & Nancy Lee H. Coombs non-building waiver: Ms. Smith explained when someone is doing any kind of construction that involves human occupancy of a space the DEP rules for managing septage. In this case the lot would require a septic system and they are asking for a non-building waiver. The SEO and Engineer make a decision which then gets passed on to the Township for approval and signatures. Ms. Hare pointed out on the plan the parcel which lies within Germany, Mt. Pleasant and a portion in Mt. Joy. She said that it is a lot combination which primarily is within Germany Township and that there is no building going on within Mt. Joy Township. Mr. Roberts moved, seconded by Mr. Mutzabaugh to authorize Ms. Jennings, as Chairman, to sign the Non-building Waiver. Motion carried unanimously.

• Conflict between private restrictions/2017 Zoning Ordinance: Ms. Smith said under the old ordinance Lake Heritage private restrictions were stricter than the Townships. Under the new ordinance the Township's restrictions are now stricter. The Board decided to amend Section 302 of the ordinance and set June 21, 2018 for the public hearing. Mr. Roberts moved, seconded by Mr. Mutzabaugh, to recommend the Board of Supervisors adopt the ordinance amending Section 110-302 to provide for setbacks in a planned community existing at the time of adoption of the Zoning Ordinance. Motion carried unanimously.

**Adjournment:** Mr. Mutzabaugh moved, seconded by Mr. Roberts, to adjourn the meeting. Motion carried unanimously. Meeting adjourned 8:35 p.m.
