-Supervisors Snyder, Moul and Hilbert along with Secretary attended the PSATS Convention at Hershey.

-Mays' Supervisors meeting will be held on Wednesday, May 6 in lieu of Thursday, May 14. Secretary will advertise.

-Don Moul has received complaints concerning the area across from the High's Store. The Supervisors will inspect the area and send the appropriate letter.

-Complaints concerning a junk condition on the Barlow Two Taverns Road and Route 134 intersection. Supervisors will find out who the owner is and send the appropriate letter. -Questions concerning the property on the corner of Hoffman Home Road and the Harney Road. The Barn is being fixed with out a permit. Supervisors will look into and send appropriate letter.

Floor:

-Steve Maitland was present and introduced himself to the Supervisors and citizens. He is running for State Representative and will be available after the meeting for any questions. -Steve Kelly - Question the trailer on the Ronald Gladfelter property. This will be looked into along with the letter from Shirley Gladfelter noted earlier. Questioned trailer on Calvin Keefer property. He claims there is water and electric hook up to this trailer. The Supervisors will make an inspection of this property and take appropriate action.

-Ellie Bennett asked about the commercial for sale or lease sign at the corner of Plunkert Road and Route 97. Answered that as long as it is rented within one year as a commercial business, it can stay as such.

-Betty Savidge asked what will happen at Heritage Drive and 97 since the negotiations fell through. Who will pay for the improvement? Answered that any future developers can carry some of the burden but the tax payers will also have to carry some. It was noted that the opportunity for developers to pay for the entire improvements fell through with the negotiations to share Heritage Road.
