Eileen Holmes- Questioned why more of the township's money wasn't in ACNB. Dayhoff responded that interest rates were better at other banks.

Waybright made motion to approve the March report, Beebe 2nd. Dayhoff questioned who or what is the Carroll Water System on the report. Attorney Davis suggested getting a copy of the bill. Carried unanimously.

Gil has signed the modules. Waybright made motion to send modules to DEP, 2nd by Beebe, carried unanimously. Waybright made motion to approve the subdivision contingent on DEP's approval, 2nd by Beebe, carried unanimously.

Road Report:

Beebe questioned whether the mower the township owns could have a boom added to it and was this being considered? Yes, it was. The price from Alamo is \$13,019.20 on a state contract which would be the cheapest way to go. Motion was made by Waybright to adopt a resolution to join the Commonwealth of Pennsylvania Cooperative Purchasing Program, Beebe 2nd, carried unanimously. We will install boom, there may be a delivery charge. Beebe made motion to accept U.S. Municipal quote and to purchase boom from Alamo, Waybright 2nd, carried unanimously.

Gavin would like to go to LTAP programs (free of charge) in Gettysburg on June 3 & 4, Dayhoff made motion to approve the request, Waybright 2nd, carried unanimously.

Street lights will be installed on the corner of Miller and Hickory Road. Contacted GPU to install.

New Business:

Ag Land Preservation rumors put to rest that the township is putting \$800,000 into the program. Supervisors gave the solicitor approval to check into joining program. Mr. Davis has contacted and is waiting a response.

The Planning Commission has requested that the SEO attend their next meeting to further explain the spray irrigation system. Supervisors should check with DEP & Gil to see what township needs re: agreement. Solicitor Davis commented on the Sunshine Law in regards to the chairman being responsible for bringing in professionals when required. Beebe made the motion to approve the chairman responsible for calling in professionals, Waybright 2^{nd} , carried unanimously.

Dry Hydrant-there is a request by citizens on California Rd. to install dry hydrants. Details need to be worked out. Waybright not comfortable with installation, not sure township getting value per \$\$, however in favor of the program. Attorney Davis has concerns with the "generic agreement", not sure it covers all the bases. He has rewritten it. The fire chief will be responsible for who gets the water, not the landowner. It will be set up for two years and the landowner must give nine months notice if they don't want the system any longer. Dayhoff made motion to adopt a township policy to be in the Dry Hydrant program with the stipulation that each project be approved by the supervisors separately with the engineering specs and cost of the project to be reviewed before approval and the landowner has to sign the access and water usage agreement drawn up by the township and the township written approval from the responding fire chief. Waybright 2nd, he wants to make sure the township is getting the most for their money. Carried unanimously.

Disposal of outdated materials- because of unnecessary controversy over disposal of outdated materials, a list was drawn up of items to be disposed of. The public was invited to review the list.

Vertical Blinds- motion was made to look for blinds at cash/carry outlet. Mats- motion by Waybright to purchase 6 floor mats from Reliable, 2nd by Dayhoff, carried unanimously.

Office hours- new office hours will start May 4 as follows Monday and Wednesday 10 a.m.-2 p.m., Tuesday and Thursday 10 a.m.-6 a.m.. The night of the monthly meeting the office will remain open until meeting time. Motion made by Waybright to approve new hours, 2nd by Beebe, carried unanimously.

Meeting table-motion by Waybright to purchase new meeting table at a price of \$690.00, 2nd by Dayhoff, Beebe abstained.

Typewriter- motion by Dayhoff to purchase new typewriter not to exceed \$500.00, 2nd by Waybright, Beebe abstained.

There will a meeting held April 29, 1998 at the Gettysburg Fire Hall re: EMA, Gavin showed an interest in attending. Dayhoff motioned to send Gavin, 2nd by Waybright, carried unanimously.

Dobos- made comment as to why public comment portion of meeting was moved to the beginning of the agenda. Response was made, to give the public a chance to respond to the agenda before the supervisors make their decisions on items.
