Reece and Rebecca Swatsworth - Preliminary plan; Planning Commission will review. Located at corner of Baltimore Pike and Two Taverns Road; 2.5 acres and house will be retained; 5.7 acres to be integrated into property next door. Flood plain on property. Snyder moved to accept the preliminary plan subject to Form B and approval from DER, Hilbert 2<sup>nd</sup>, motion carried.

## Road Report:

Three Foot plastic pipe ordered for Barlow-Two Taverns Rd. Mowing is being done. Preparations being made to widen Schottie Rd. for paving.

Hillside Estates meeting re: Curbing scheduled for July 29, 1993, 7:30 p.m. at the Twp. Municipal Building.

An estimated proposal has been received from HRG, the engineering firm for the Rt. 97/Lake Heritage project of widening the road from Rt. 15 to White Rd. and making turning lanes into Lake Heritage and the 7-11 store. HRG will do surveys, preliminary designs, sections and sketches and roadway construction plans. The estimated fee for HRG is \$28,500. Snyder moved to instruct HRG to continue with the project.

-Letters from DER re: sewer districts. County association of supervisors met on June 21, 1993. A representative from Representative Maitland's office attended. There seems to be misinformation regarding Act 537 and concern over whether the Townships must go to a sewer district. Representative Maitland has been working on this for two to three months. Letters have been received from DER stating that sewer districts are not mandatory. There is a six-member committee for the state to solve problems. These letters will be retained in the Township files.

-Solid Waster – County is trying to locate a site for a composting facility. Thirty-six possible sites from the Rt. 97 interchange to Rt. 234 in Tyron Twp. have been narrowed down to three sites. Decision will probably be made within the next two months. The municipal solid waste plan must be updated to comply with Act 101.

Old Business:

Fire Companies: In accord with the request by the Township auditors, Barlow, Bonneauville and Littlestown say they will give a letter regarding how the funds were sued. A letter will be sent to the Gettysburg Fire Department. Gettysburg also needs to give the Township information regarding its fire district.

PA 97 - PennDot may pay for the drainage ditch.

Junk Yards - Mrs. Racine will not receive a license at this time.

New Business:

Marty Miller had a complaint that two persons impersonating DER inspectors were on his property Saturday, July 3<sup>rd</sup>. Township is investigating this. Mr. Miller called DER - they say they were not out.

Public Comments: There were no comments from the floor.
