# New Business:

The National Convention of Township Supervisors will be held Sept. 9-11 in Washington DC. Harry may attend and will make a decision early next week. If Chairman Hilbert attends the Convention the Township meeting will be changed to September 15. There will be a notice in the paper IF the meeting is to be changed.

## **Public Comments:**

Terry Monn was present asking if there was a possibility to have a street light put up at the White Road/Route 97 interchange. The supervisors will discuss this and make a decision. It was noted that each light costs approximately \$200.00/year.

Bob Gitt was present and noted that there was another accident at this property on March 3, 1992. In this case, the car ran off of the road and struck his barn, causing considerable damage. Supervisor Moul asked if Mr. Gitt would like to have the Supervisors contact PennDot again and try to have the speed limit lowered to 45 mph. Mr. Gitt noted that he speed limit would not make any difference, but they could try. Mr. Gitt feels that the only solution is to get the farm equipment off the road by making the area in question zoned commercial.
