The Mount Joy Township Supervisors held their regular monthly meeting on Monday, July 11, 1994 at 7:30 p.m. in the Township Municipal Building located at 902 Hoffman Home Rd., Gettysburg, PA. All members were present.

The minutes of the last regular monthly meeting, June 13, 1994, were approved by motion of Snyder, 2nd by Moul. All in favor, motion carried.

The Treasurer's Report and Bills to be Paid Report consisting of \$11,260.88 to be paid out of the General Account, checks numbered 6984 through 7002 and \$2,458.23 to be paid out of the Payroll Account, checks 1317 through 1326 were approved by motion of Moul, 2nd by Beebe. All in favor, motion carried.

Motion made by Snyder to award bid to Hammaker, 2nd by Beebe. All in favor, motion carried.

Road Report

A temporary 20' road will be installed from the end of White Road to Heritage Drive. L. L. White's will cut trees. It is anticipated that Heritage Drive will close 8/15/94 for approximately two weeks while working on Rt. 97 directly in front of Heritage Drive. Time must be allowed for concrete to cure. Moul moved for a letter to be written to the residents of White Road advising them of these plans. 2nd by Beebe. All in favor, motion carried.

Signs directing the detour will be posted; also possible 25mph.

Floyd Huff mentioned that there is a bad place on Speilman-Klinger Rd. due to washing due to recent storms.

Mr. Beebe mentioned that there is also a bad pot hole on Md. Line Rd.

A pipe has been damaged on White Church Road. Hinkles-McCoy will fix this.

Old Business:

The EMA Resolution was adopted on a motion by Moul, 2nd by Beebe. All in favor, carried.

Snyder reported that Don Hubbard has turned down the position of Emergency Management Coordinator. Special training courses must be taken for floods, natural disasters, etc. This is an unpaid position.

Building Permit and Zoning Officer - Building permits have been being issued from the office. Currently do not have a zoning officer. Set-back lines biggest issue, also permitted use.

The issue regarding Les Adam's porch has been resolved.

The Township will pay Dean Shultz's bill. Mr. Beebe thinks it is high; made motion to pay it, 2nd by Moul. All in favor, carried.

New Business:

Admissions Tax Ordinance - This tax (10%) is already being collected; School Board is getting it all. The Twp. is going to claim 5% of this tax, but can't get it until next year because the School Board has it budgeted for this year. This ordinance is not creating a new tax; is just claiming half that the Twp. should be receiving. (Act 511-Tax Enabling Act)

Floyd Huff questioned if this applies to the pool at Lake Heritage. Mr. Moul responded that people who pay dues there get a pass. People who don't live there but are there as quest must pay \$2.00 to swim. The pool is actually located in Mount Pleasant area of the Lake Heritage.

Motion by Moul to adopt the ordinance, 2nd by Snyder. All in favor, motion carried.

John McAlister's letter regarding son's request for Junk Yard - Supervisors and son are working this out.

Floyd Huff questioned the large hole being dug at Martell's Junk Yard. The state (DER) is requiring them to do this; not the Twp. This is DER's responsibility.

Public Comments:

There was a question regarding whether the Twp. has a mowing program in effect this summer. Snyder responded that mowing is about three weeks behind schedule.

Mr. Knisley had questions regarding the letter received about this junk yard. Says he has taken care of the tires on the flood plain, has moved about 40 tons out, has not moved anything in except machinery that he is fixing up to clean up the place. Sixty-six tires have been removed; 12 still there. Mr. Knisley's son said that piles of junk were put there as junk, but contain valuable antiques. Wood can be used or stove. Son suggested meeting at the site with the supervisors. This will be done at 8:00 a.m. Wednesday. (7/13/94) A copy of the Junk Yard Ordinance is to be given to Mr. Knisley.

Mrs. Holmes - Feels an air conditioner is needed for the Township Bldg. \$16,000.00 being spend on signs for the Rt. 97 project and will they belong to the Twp? Also questioned the bills from Swope, Heiser and McQuaide.

Floyd Huff inquired as to the status of Codification. Mr. Beebe replied that it is just about ready to go to the printer.

Mrs. Holtz expressed concern over the amount of signs (realtor and personal) at the White Church Rd./Rt. 97 intersection. This is dangerous; can't see up and down road.

Mrs. Holmes stated that if someone else is hired who is in the National Guard, they can't be denied their week to go. Mr. Beebe responded that Mr. Smith (Larry) didn't notify the Twp. that so much time would be required.
