A letter was read from Dean Shultz concerning the enlargement of the Hoffman Home Sewer Treatment Plant. A sewer module was presented to the township from Hoffman Home for enlargement of their plant. Motion by Snyder, 2nd by Hilbert to accept this sewer module for enlargement of their plant, carried.

A letter from the DER was received concerning the module application for the 6-lot residential development on 10+ acres of James Hunt, Jr. The following items required for

this module are as follows: 1. Municipal transmittal letter, 2. Component II., 3. Component III, 4. Sit investigation and percolation test reports (form ER-BWQ-290 Appendix A) for all soil tests conducted, 5. Plot plan (containing all the information required by Component III., 6. USGS quad sheet or equivalent site location map, 7. Project narrative (describing the size and type of developmental daily sewage flows, and long term sewage disposal needs of the development.), 8. Sewage Enforcement Officer comments regarding the suitability of the site for on-lot sewage disposal systems, in the even the municipality determines your project requires a revision to its Official Sewage Plan, the following two (2) items must also be included with the module: 9. Municipal resolution of adoption, 10. Adams County Planning Commission comments on the proposed revision.

Letters were received for the Littlestown and Gettysburg Rec Boards wanting our continued financial support for 1985.

Hockley and O'Donnell were retained as township insurance agent for all coverage for township.

A motion was made by Snyder to adopt the fee schedule for enacting "Act 537," the sewage facilities act, 2nd by Hilbert, carried. The fees are the same as 1984.

Letter was read from the Department of Transportation concerning driveway occupancy permits for all new sub-divisions when entering from state highways, We are to urge the people to get the necessary permit.
