APRIL 16, 2009 SUPERVISORS' MEETING:

The Mount Joy Township Board of Supervisors met this date, as publicly advertised, at 7:30 p.m. in the meeting room of the Mount Joy Township Municipal Building, 902 Hoffman Home Road, Gettysburg, PA 17325 with Board Chairman James W. Waybright presiding. Walton V. Davis, Solicitor, was not present.

Treasurer's Report:

Mr. Chantelau moved, seconded by Mr. Scott, to approve the Treasurer's Report as presented. Motion carried unanimously.

Mr. Scott moved, seconded by Mr. Chantelau, to approve the bills to be paid as presented. Motion carried with Mr. Dayhoff abstaining.

Other Business:

Ordinance No. 2009-02: Mr. Chantelau moved, seconded by Mr. Scott, to adopt Ordinance No. 2009-02, Amendment to the Zoning Ordinance for SVSC relative to steep slopes and building setbacks. Discussion: Mr. Chantelau noted the Planning, Land Use & Zoning Committee previously met with Township Engineer and Horizon Group representatives to walk the site regarding steep slope issues/concerns. Everyone then met with the solicitor to talk about technical aspects of slopes, man-made versus natural, and developed language for this proposed ordinance. Hearing on the proposed ordinance was held prior to this meeting. Motion carried unanimously.

<u>Well Ordinance Amendment:</u> Mr. Chantelau moved, seconded by Mr. Scott, to remove the well ordinance amendment from the table. Motion carried unanimously.

Mr. Chantelau explained the Planning, Land Use & Zoning Committee was directed last month to review the proposed amendment; they did so with township engineer and solicitor. The amendment includes information regarding geothermal open loop systems. Mr. Chantelau moved, seconded by Mr. Scott, to set a special workshop meeting to discuss open loop systems with a target to adopt a well ordinance amendment by the June meeting. Motion carried unanimously.

Subdivision/Land Development Plans:

Horizon Group Properties, Inc.: The Gettysburg Outlet Center, LLC: proposed LDP for Phase IIB. Planning Commission recommends approval with contingencies. Discussion held on contingencies. Mr. Dayhoff moved, seconded by Mr. Scott, to approve as a preliminary plan, approve a modification request regarding curbing, and meet the requirement by the fire company to install all three hydrants for Phase II buildout. Motion carried unanimously.

Road Report:

Mr. Chantelau moved, seconded by Mr. Scott, to accept the Road Report as presented. Motion carried unanimously.

Invitation For Bid - Seal Coat and Asphalt: With recommendation from Sam Dayhoff, Road Superintendent, Mr. Scott moved, seconded by Mr. Chantelau, to authorize the advertisement to accept bids for seal coat for various township roads, and asphalt for Heritage Drive project, and to set the date for bid opening at May 21 2009 at 7:30 p.m. Motion carried unanimously.
