Meeting Minutes

The Mount Joy Township Board of Supervisors met this date, as publicly advertised, at the Mount Joy Township Building located at 902 Hoffman Home Rd., Gettysburg, Pennsylvania.

PUBLIC HEARING

Call to Order: Public Hearing Meeting, duly advertised, opened at 7:01 p.m.

Chairman, John Gormont presiding.

Sheetz Intermunicipal Transfer of Liquor License for; (i) sale of beer for on-site consumption and to go and; (ii) sale of wine to go

Ms. Smith explained that the public hearing is required by state law for the transfer of a liquor license into the township. The proposed site for the license is the Sheetz on Rte. 97. At the conclusion of the public hearing, the Board will need to make a decision based on findings of facts based on information received tonight. Should the Board decide to act on this liquor license transfer it would be handled through a resolution.

Paul Namey, attorney representing Sheetz explained how they came to apply for the transfer of the license. He presented a floor plan of the store highlighting the location of the designated register for gas purchases and also where the beer will be located within the store. He then presented facts on how Sheetz has handled the sale of beer and wine in other locations.

Public Comments: Carol Holtz – questioned who monitors the consumption of beer within in the dining area? Mr. Namey stated that there are two dedicated managers, the overall store manager and then the liquor code requires a restaurant manager who devotes their full time attention to the operation of the restaurant. Ms. Holtz questioned about cameras outside to monitor that someone is not buying the alcohol and then drinking in the parking lot. Mr. Namey affirmed that, as previously stated, at other locations they have not experienced any issues, including two college towns.

Ms. Holtz had another concern being the intersection. It is a very dangerous intersection.

Steve Wentz - Questioned if the resolution would specify that a customer is only permitted to consume two beers in the restaurant. If the liquor control board increases the amount consumed would Sheetz come back before the Board for approval? Ms. Smith said the Board's action is based on findings of facts presented tonight. Among those findings of facts will be the representation of Sheetz' policy is to limit on-site consumption of beer to two cans or two bottles.

Mr. Updyke moved, seconded by Mr. Trostle, to close the public hearing. Motion carried unanimously.

Business:

- Zoning Ordinance Consideration and vote upon enactment of amendment to provide standards and requirements relating to parking commercial and recreational vehicles, as revised following public hearing: Ms. Smith said that the revisions made were for clarification and not substantial changes. The determination was made at the workshop meeting that these are not substantial changes and there is not a need for another public hearing. Mr. Bowman moved, seconded by Mr. Clark, to adopt Ordinance 2017-01 as revised per public hearing comments. Ayes Mr. Bowman, Mr. Clark, Mr. Gormont, Mr. Updyke. Nay Mr. Trostle. Motion carried.
- Gettysburg and Littlestown Recreation Distributions: Mr. Gormont said that the Township annually contributes a total of \$8,000.00 which is split evenly (\$4,000.00 to Gettysburg Recreation Department and \$4,000.00 to Littlestown Recreation Department. He would like to get authorization from the Board to distribute this year's money. As reported in the audit report this contribution was missed last year. Mr. Gormont would like to make an \$8,000.00 contribution to each to make up for last year. Mr. Clark, moved, seconded by Mr.

Trostle, to approve the distribution of \$8,000.00 to both Gettysburg and Littlestown Recreation Departments. Motion carried unanimously.

- Links at Gettysburg extension request for final plan submission for Fryer tract: Mr. Gormont said that we received a letter from the Links at Gettysburg requesting a one year extension for the submission of the plans for the Fryer tract. Mr. Gormont went on to read a letter addressed to Mr. Klein from Susan Smith stating the he no longer meets the MPC requirements of being a legal applicant. Mr. Gormont said we have not received anything from Mr. Klein. Ms. Smith said she received a response that Mr. Klein is working on this issue. The Board did not take any action at this time.
- Well Citations: Mr. Gormont said that back in 2007 there were seven wells drilled for a development. There were no land development plans submitted and the whole idea went away. He said this was for the Ramsburg tract. The ordinance states that any well drilled and abandoned for a year needs to be decommissioned. Mr. Ramsburg came into the office today to ask if he put a hand pump on the wells would that be sufficient. Mr. Gormont said he feels it is well beyond the timeline to decommission the wells. Ms. Smith said there is a one year abandonment standard. If the well is not used for one year it is considered abandoned and needs to be decommissioned. These wells have not been used. Ms. Smith said the other issue is if they are recommissioned will they meet the standards in the ordinance. Mr. Bowman asked if there is a plan in the works. Mr. Gormont said they need to understand that there was never a plan submitted. Ms. Hare said there were well permits issued, however, the application was made by the developer and not the land owner. Ms. Smith said that he was notified twice in writing and we received no response. He was then cited. Mr. Gormont questioned if the Board needs to take any action on this. Mr. Gormont said that it appears the Board's determination is that the wells need to be decommissioned. Ms. Smith said that if the Board feels the staff is taking the appropriate action then there is no need to act.
