The Mt. Joy Township Supervisors held their regular monthly meeting on Wednesday, March 10, 1982 at 7:00 p.m. at the township municipal building on Hoffman Home Road. All members were present.

The minutes were approved by motion of Glenn Snyder, 2<sup>nd</sup> by Harry Hilbert, carried.

The treasurer's report was approved and bills to be paid by motion of Jim Neth, 2<sup>nd</sup> by Snyder, carried.

Ted Taylor from Gladfelter's Insurance of York was present to talk about a workman's compensation program that the township association is planning on maintaining. Right now, there would be no advantage for the township to participate in this program, but maybe in the next few years there would be reason for the township to do so, as there could be an accumulation of dividends. So, for the present time, the supervisors decided to stay with Hockley and O'Donnell of Gettysburg. "Skip" Hockley was present to discuss this years renewal policies and he explained a little more about the program that Mr. Taylor presented. He will also work up a quote on our Errors and Omissions policy. A motion was made by Hilbert to renew insurance as is, 2<sup>nd</sup> by Neth, carried.

Snyder talked to D.W. Miller Industries about sweeper. Price around \$4,500.00. Must bid on items over \$4,000.00. Neth made motion to proceed with bids on road sweeper, 2<sup>nd</sup> by Hilbert, carried. Secretary instructed to bid on this item and the bids to be opened April 14, 1982.

Also, secretary instructed to bid on oil and stones by motion of Neth, 2<sup>nd</sup> by Hilbert, carried. Bid as follows:

E-3 50,000 gallons

2's 1,000 tons

2A 2.000 tons

1B 500 ton

anti-skid 500 tons

Bids to be opened April 14, 1982.

Planning Commission still has no one to fill the "vacancy."

Township still owes Roadite \$14,000.00. - Snyder made motion to pay \$10,000.00 of balance due,  $2^{nd}$  by Neth, carried.

Road inspection to be on Saturday, March 27 or April 10.

Road takeover - Charles Scott here to discuss this, also Germany Township supervisors. Roads to be obtained by township include;

Barlow Road (Rt. 97 to Orphanage Rd.) 2.8 mile - O.K. condition.

Bulk Plant Road - 1.5 mile - needs some repairs

Fish & Game Road - 1.89 mile - needs resurfaced.

Harney Road - 1.5 mile - O.K. condition

Mason-Dixon Road - 1.25 mile - needs resurfaced.

State will send resolution on Barlow and Harney Road.

Meeting adjourned at 9:10 p.m. by motion of Neth, 2<sup>nd</sup> by Hilbert, carried.
