June 9, 1988

The Mt. Joy Township Supervisors held their regular monthly meeting on Thursday, June 9, 1988 at 7:30 p.m. at the township municipal building on Hoffman Home Road. All members were present.

The minutes were approved by Glenn Snyder, 2nd by Wilbur Danner, carried.

The treasurer's report and bills to be paid were approved by motion of Snyder, 2^{nd} by Danner, carried.

Bids for FB1 were opened at 7:30 p.m. Following are the bids that were received:

Hammaker - 3,200 ton FB1 Wearing Course in place @ 22.10 = \$70,720.00 1,300 ton FB1 Binder Base in place 19.28 = \$25,064.00 \$95,784.00

Roadite - 3,200 ton FB1 Wearing Course in place @ 22.92 = \$73,344.00 1,300 ton FB1 Binder Base in place 19.99 = \$25,987.00 \$99,331.00

Bid was awarded to Hammaker by motion of Glenn Snyder, 2nd by Harry Hilbert, carried. Plans of Leonard Mohr (Mr. Harris) - will be taken under advisement with solicitor.

Plans of the former Merv Weikert property were brought in by Mr. Kraus - he was told that we would have to take them first to the County Planner and then to township Planning Commission for approval and then be brought back to township.

Moses Stoltzfus plans were approved by motion of Snyder 2nd by Wilbur Danner, carried.

The Luther Angell plans were approved by motion of Snyder, 2nd by Danner, carried.

The Hazel Crouse plan was brought back to the township for reapproval. Snyder reapproved the plans, 2nd by Danner, carried. (The reason for reapproval was that the plan wasn't recorded within the proper time period.)

Ron Barrick wants to give supervisors insurance coverage quote for the year 1989 year. Told him to contact supervisors in January of 1989.

Letter from United Telephone that they will be placing a buried telephone cable under T-418 (Cemetery Road) at one location. This will be both for telephone and electric service to a new home that Mr. Plank is constructing along Cemetery Road. He confirmed that he will apply for all necessary highway occupancy permits.

Budget for Adams County Earned Income Tax Collection Agency was reviewed by the Supervisors. Total budget for the 1988-89 year is \$155,300.00.

A letter was read from Mr. Teeter that Mr. Hartman wrote him concerning perc but the state which mandates that all land must have percolation tests.

Russell Burr - complained about junk yard on the McAlister property. Also about a three wheeled vehicle race track on the same property. Supervisors advised that the junk yard is more than 500 feet from the road.

Junk Yards - Hollinger, Davies and Hartlaub have not responded to the letter that was sent to them regarding junk yard licenses. Another letter is to be sent to these three property owners concerning this.

Jake Stoltzfus - Has two mobile homes on his present property at two different locations. He has a percolation test done at the one site and would like to move both

mobile homes to the same location on his farm. Supervisors would like to see both the mobile homes moved together but now allow any further development on his farm unless he gets a 50 foot strip of land owned by him to a public road. Check with solicitor on this matter.

Flood Plain - nothing further to report.

Mr. Mearns was complaining about the water from the golf course flowing onto his property that Mr. Kehr is renting from. Supervisors to make gutter along the road deeper on his property to try to help keep the water from going into his field.

John Schwartz and Mildred Benner, township auditors, were present and they want a record kept of the amount of fuel that is used in each vehicle and the hours or miles recorded.
