June 8, 1979

The Mt. Joy Township Supervisors held their regular monthly meeting on Friday June 8, 1979 at 7:30 p.m. at the township municipal building on Hoffman Home Road. All members were present.

The minutes were approved by motion of Wilbur Danner, 2nd by Willis Waybright, carried.

The Treasurer's report was approved by motion of Danner, 2nd by Waybright, carried.

There was a public hearing concerning the adoption of a revision of the subdivision ordinance by the Township. One person was present, Mrs. Eileen Holmes, and she did not voice any opinion on the matter. Glenn Snyder made a motion that, since a public hearing was held to receive comments on the revision of our subdivision ordinance and since no unfavorable comments were hear, that the Supervisors adopt the new ordinance as advertised. This motion was seconded by Danner, motion carried.

Martin and Sherrill requests that he be released for a least part of the money (75%) of the \$96,000.00 that he presented as security. This is to be applied to his letter of credit for the building of Hillside Estates. The Supervisors discussed this matter among themselves and also with their solicitor, Sam Teeter, who was present at the meeting. They agreed to reduce this amount to \$40,000.00. Sam Teeter is to send letter to their attorney and also to the bank advising them of the Supervisors decision.

There was only one bid received for FB-1 Binder and FB-1 Wearing Course. That bid was from Roadite as follows:

FB-1 Binder Course \$14.47 per ton for a total of \$11,937.75

FB-1 Wearing Course \$17.26 per ton for a total of \$60,410.00

Total cost is \$72,347.75

A motion was made by Danner, 2nd by Snyder to accept this bid, motion carried.

A representative was present from Hockley and O'Donnell Insurance Agency in Gettysburg to discuss with the Supervisors the possibility of putting all insurances together with their company. He is to work on a proposal and present it at the next meeting of the Supervisors on Thursday July 12, 1979.

A motion was made by Snyder for the solicitor to find out final figure due for Pa. Dept. of Revenue for township's failure to pay taxes by former secretary 2nd by Danner, carried. Sam is to report at next meeting on final figure.

There was a discussion of fireman's compensation, Snyder said \$300.00 or 30% is what we should pay. Supervisors will take final action on this subject at their next meeting.

Sam Teeter is to advertise the Junk Yard Ordinance in the paper.

Secretary to advertise change of meeting notice in the paper and also post sign on Township building advertising the change of meeting.

Meeting adjourned at 10:00 p.m. by motion of Snyder, 2nd by Danner, carried.

Next meeting will be held on Thursday July 12, 1979 instead of Friday July 13, 1979. Meeting will be held at 7:30 p.m. at the Township Municipal Building.
